**Institute Financial Assistance For SC/ST Students (Freshers) During the  
Session 2016- 2017**

Like previous sessions the Institute will operate in the current Session 2016-2017 the scheme of financial assistance to SC/ST students (free messing, pocket allowance Rs. 250/- per month and exemption from paying seat rent) who will fulfill the following criterion :-

**“The guardian’s annual income ( for both salaried and non-salaried persons)  
should not exceed Rs.50,920.00.”**

1<sup>st</sup> year UG students of 2016–2017, 1st year students of M. Sc. (2-year) courses and Preparatory Course (2016-2017) admission) students are required to submit their guardians’ income certificate in the prescribed form (to be collected from ACADEMIC (UG) SECTION between 3.00 P.M. to 5.00 P.M. on all working days) for the financial year 2015-2016(i.e. from 1<sup>st</sup> April, 2015 to 31<sup>st</sup> March, 2016) **to the ACADEMIC (UG) SECTION on any working day within September 30, 2016.**

**Renewal of Institute Financial Assistance for SC/ST students  
during the session 2016-2017.**

Income Certificate / Income Affidavits in the prescribed forms are also invited from the SC/ST students of 2<sup>nd</sup>, 3<sup>rd</sup>, 4<sup>th</sup> & 5<sup>th</sup> year who were in receipt of Financial Assistance comprising of Free Messing, Pocket Allowance Rs. 250/- per month and exemption from paying Seat Rent in the Session 2015-2016 which may be submitted **to Academic (UG) Section on or before September 16, 2016.**

**DOCUMENTS TO BE SUBMITTED IN SUPPORT OF PARENT'S/  
GUARDIAN'S ANNUAL INCOME ALONG WITH THE FINANCIAL  
ASSISTANCE APPLICATION :**

**FOR SALARIED CLASS :** An Annual Salary Certificate from Salary Disbursing Officer of the employee in prescribed Form "A".

**FOR RETIRED PERSON / PENSIONERS :** A Certificate from the Ex-Employer/ Pension Payment Authority as the case may be, about their Annual Pension + Relief etc. received during the Financial Year 2015-16, in prescribed Form "C" in addition to IT Form 16, , as applicable.

**In case of persons retired from a Private Firm ( not in Pension Scheme),** they are required to submit all the income documents received towards Retirement benefits, VRS etc. along with Income Tax Documents as applicable in addition to an Income Affidavit in prescribed Form "B" on a Rs.20/- Non-Judicial Stamp Paper sworn in before a First Class Magistrate.

**FOR ALL OTHER CLASSES :** (Such as Businessman, Medical / Legal Practitioner, Agriculturist, Investors, Self-employed persons, other than Salaried Class/Pensioners) : An INCOME AFFIDAVIT for the Financial Year 2015-16 (From 1<sup>st</sup> April, 2015 to 31<sup>st</sup> March, 2016) in prescribed Form "B" on a Rs.20/- Non-Judicial Stamp Paper sworn in before a First Class Magistrate. A copy of Trade/Profession License from competent authority may also be submitted as applicable.
