1) Punishments to Mr. Bobde Aniket Anant, Roll No. 14MT30031 :

- He be suspended from the Institute for one semester starting from Autumn Semester 2017-2018 and he will be allowed to rejoin the Institute in Spring Semester 2017-2018.
- He be directed to vacate the hall of residence and leave the campus immediately.
- He be debarred from being considered for the purpose of getting Institute medals/awards/prizes/scholarships etc.
- He be debarred from taking part in any Gymkhana activities.
- His parents be informed.

2) Punishment to Ms. Simran Kaur, Roll No. 14AR10032 :

- She has to give service to the Library for 15 hours for two weeks with effect from the date of issuance of the office order
