In terms of the Institute approved Recruitment and Promotions Rules (R&PR), the Hall Management Centre (HMC) invites applications as per prescribed format from the eligible regular staff members of the HMC for the following posts.

1. Post: Manager Gr. I

Pay Matrix Level: Level-8 of Pay Matrix ₹47600-151100/- and other allowances as admissible.

Minimum Educational Qualification: Bachelor's degree in any discipline,

Experience: Minimum 8 years (selection) or 10 years (non-selection) of relevant experience in the HMC in Level-7 of Pay Matrix ₹44900-142400/- (Pre-revised: PB-2, GP ₹4600/-) holding the post of Manager Gr. II or equivalent level.

2. Post: Manager Gr. II

Pay Matrix Level: Level-7 of Pay Matrix ₹44900-142400/- and other allowances as admissible.

Minimum Educational Qualification: Bachelor's degree in any discipline.

Experience: Minimum 8 years (selection) or 10 years (non-selection) of relevant experience in the HMC in Level-6 of Pay Matrix ₹35400-112400/- (Pre-revised: PB-2, GP ₹4200/-) holding the post of Manager Gr. III or equivalent level.

Minimum Educational Qualification and Experience: Bachelor's degree in any discipline OR Senior/Higher Secondary (10+2) pass.

Experience: Minimum 8 years (selection) or 10 years (non-selection) of working experience in the HMC in Level-3 of Pay Matrix ₹21700-69100/- (Pre-revised: PB-1, GP ₹2000) holding the post of Supervisor.

6. Post: Supervisor

Pay Matrix Level: Level-3 of Pay Matrix ₹21700-69100/- and other allowances as admissible.

Minimum Educational Qualification: Bachelor's degree in any discipline OR Senior/Higher Secondary (10+2).

Experience:

- (a) The employee with Minimum 5 years (selection) of relevant experience in HMC in Level-2 of Pay Matrix ₹19900-63200/- (Pre-revised: PB-1, GP ₹1900) holding the post of Mess Assistant Gr. III OR 5 years (selection) of relevant experience in HMC in Level-3 of Pay Matrix ₹21700-69100/- (Pre-revised: PB-1, GP ₹2000) holding the post of Cook. OR
- (b) The employee with Pay Matrix ₹18000-56900/- (Pre-revised: PB-1, GP ₹1800/-) holding the post of Mess Assistant or equivalent level who have completed 5 years of service and possess a minimum Bachelor's degree in any discipline along with 6 months of Computer Application knowledge.

7. Post: Cook Gr. I

Pay Matrix Level: Level-6 of Pay Matrix ₹35400-112400/- and other allowances as admissible.

● **Minimum Educational Qualification:**

- (c) Matriculation or equivalent pass certificate / diploma in Catering Institution/organization;
OR (10th Pass) from a recognized board with a from Central/State Govt. of recognized; OR
- (d) The employee with Matriculation not having a certificate/ diploma in Catering may be considered for the post provided he/she has undergone at least 12 (twelve) weeks of specialized training in the relevant field and completed training successfully with Grade A (80 percent marks and above) after becoming Cook Gr. I.

Experience: Minimum 8 years (selection) or 10 years (non-selection) of relevant experience in the HMC in Level-5 of Pay Matrix ₹29200-92300/- (Pre-revised: PB-1, GP ₹2800/-) holding the post of Cook Gr. II or equivalent level.

8. Post: Cook Gr. II

Pay Matrix Level: Level-5 of Pay Matrix ₹29200-92300/- and other allowances as admissible.

Minimum Educational Qualification:

- (a) Matriculation or equivalent pass (10th Pass) from a recognized board; OR
- (b) The employee not having Matriculation or equivalent pass may be considered for the post provided he/she has undergone at least 12 (twelve) weeks of training in the relevant field and completed training successfully with Grade B (70 percent marks and above)

Experience: Minimum 8 years (selection) or 10 years (non-selection) of relevant experience in the HMC in Level-4 of Pay Matrix ₹25500-81100/- (Pre-revised: PB-1, GP ₹2400/-) holding the post of Cook Gr. III or equivalent level.

9. Post: Cook Gr. III

Pay Matrix Level: Level-4 of Pay Matrix ₹25500-81100/- and other allowances as admissible.

Minimum Educational Qualification:

- (a) Matriculation or equivalent pass (10th Pass) from a recognized board; OR
- (b) The employee not having Matriculation or equivalent pass may be considered for the post provided he/she has undergone at least 12 (twelve) weeks of training in the relevant field and completed training successfully with Grade B (70 percent marks and above)

Experience: Minimum 8 years (selection) or 10 years (non-selection) of relevant experience in the HMC in Level-3 of Pay Matrix ₹21700-69100/- (Pre-revised: PB-1, GP ₹2000/-) holding the post of Cook or equivalent level.

8. Post: Cook

Pay Matrix Level: Level-3 of Pay Matrix ₹21700-69100/- and other allowances as admissible.

Minimum Educational Qualification:


- (a) Matriculation or equivalent pass (10th Pass) from a recognized board; OR

(b) The employee not having Matriculation or equivalent pass may be considered for the post provided he/she has undergone at least 12 (twelve) weeks of training in the relevant field and completed training successfully with Grade B (70 percent marks and above).

Experience: Minimum 5 years of experience in Level-1 of Pay Matrix ₹18000-56900/- (Pre-revised: PB-1, GP ₹1800/-) holding the post of Mess Assistant or equivalent level.

4. Degree as referred above should have been awarded by a recognized University /Institute.
