



6. Complete details and specification if any must accompany the quotation. Make/brand of the item shall be stated wherever applicable. If you have got any counter offer as suitable to the material required by us, the same may be shown separately.

If there is no indication regarding the FOR, in the quotation, then it will be considered as FOR destinations.
11. In case your quotation is accepted and order is placed on you, the supply against the order should be made within the period stipulated in the order. Warden, BRH Hall, IIT Kharagpur reserves the right to recover any loss sustained due to delayed delivery by way of penalty. The store should be delivered / dispatched to destination and ready for operation not later than the delivery date specified. In the event of failure to deliver the stores beyond the specified date, liquidated damages @ 0.5% per week or part thereof in respect of the value of stores will be deducted, subject to a maximum of 10%; alternately the order will be cancelled and the undelivered stores purchased from elsewhere at the risk and expense of the vendor.
12. If the deliveries are not maintained and due to that account Procuring Entity is forced to buy the material at your risk and cost from elsewhere, the loss or damage that may be sustained there by will be recovered from the defaulting supplier.
13. Dispute clause: Any dispute relating to the enquiry shall be subject to the jurisdiction of the court at West Midnapur only.
14. Bidder must sign with seal on each page of the Limited Tender Form.
15. Bid Security Declaration in lieu of EMD: No EMD shall be deposited; however, the bidder should submit the Bid Security Declaration as per Annexure – III with the Technical bid, without which the bid shall be straightway rejected.
